AN ORDINANCE TO AMEND ARTICLE I OF CHAPTER 4.5, "BUILDINGS AND BUILDING REGULATIONS," SECTION 4.5.6, "SWIMMING POOL PERMIT, ENCLOSURE REQUIREMENTS, AND MAINTENANCE OF SWIMMING POOLS", OF THE CODE OF ORDINANCES OF LIVINGSTON PARISH.

WHEREAS, the Livingston Parish Council on July 26, 2012 added Section 4.5-6, "Swimming Pool permit, Enclosure Requirements and Maintenance of Swimming Pools" to the Code of Ordinances to make necessary and desirous updates and revisions to that section of the Code setting out in Article I of Chapter 4.5, "Buildings and Building Regulations" and

WHEREAS, the Livingston Parish Council now desires to make further amendments to Section 4.5-6, "Swimming Pool permit, Enclosure Requirements and Maintenance of Swimming Pools", by modifying the permit fee and adding a fourth violation penalty.

THEREFORE, BE IT ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana that:

ARTICLE I OF CHAPTER 4.5 BUILDINGS AND BUILDING REGULATIONS, SECTION 4.5-6, SWIMMING POOL PERMIT, ENCLOSURE REQUIREMENTS AND MAINTENANCE OF SWIMMING POOLS, of the Code of Ordinances is hereby amended as follows by changing the permit fee and adding a fourth violation penalty as follows:

**Sec. 4.5.6 Swimming pool permit, enclosure requirements, and maintenance of swimming pools.**

*1. Permit*

Before construction of an in ground swimming pool begins, a permit must be obtained from the Livingston Parish Permit Department. The cost of the "Pool Permit" is thirty-eight dollars (\$38.00).

*4. Failure to comply:*

(b)

iv. Fourth offense and thereon, from one (1) to five (5) days in jail

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

The effective date of this ordinance shall be as prescribed by law.
